## NOTICE OF REGISTRATION OF FOREIGN PARENTING ORDER

A foreign parenting order (order for child custody/parenting time/visitation /companionship) issued by an out-of-state court has been registered in Ohio in this Court under Chapter 3127 of the Ohio Revised Code. You have been named Respondent in that action.

A copy of the Petition to Register and the registered foreign parenting order is attached.

## YOU ARE HEREBY NOTIFIED THAT:

- The attached foreign parenting order is entitled to Full Faith and Credit and is enforceable as of the date of the registration in the same manner as an order issued by an Ohio court.
- You must request a hearing to contest registration within 30 days after the date you receive this Notice if you wish to contest the validity of the attached foreign parenting order. A sample "Request for Hearing to Contest Registration of Foreign Parenting Order" is available on the Court's website.
- Failure to request a hearing to contest the registration in a timely manner will result in confirmation of the foreign parenting order by operation of law, and preclude further contest of the child custody determination with respect to any matter that could have been asserted at the time of registration.

If you request a hearing, you will be notified by the Court of the date, time and place of the hearing. You are responsible for providing evidence at the hearing to prove any defense you may have to the validity of the registered order. The Court will confirm the foreign parenting order unless you can prove one of the following:

- The issuing court did not have jurisdiction to issue the order.
- The order sought to be registered has been vacated, stayed, or modified by a court having jurisdiction to do so.
- You were entitled to notice of the order, but did not receive notice of the proceedings before the court that issued the order for which registration is sought.
